

Indiana General Assembly

- 2 parts of the General Assembly: House and Senate
- 100 Representatives (serve 2-year terms)
- 50 Senators (serve 4-year terms)
- District maps available at: iga.in.gov/information/
- Even years = Long Session (budget years)
- Odd years = Short Session

Short, Specific and Memorable!

Practice, Practice! (...makes perfect!...)

THE MESSAGE: What do you need your audience to know?

THE STORY & KEY DATA: Connect the message to your work, use quick facts/data and a story!

THE ASK: Consider WHO you are talking to, what they care about, what kind of impact can they make?
