LC4, LC5, and LC6 Requirements

Librarian Certificate 4 (LC4) - Bachelor's degree from an accredited college or university and 15 college credit hours in library science (5 courses). The library science courses must be three credit hours each and may be taken as part of the bachelor degree curriculum, or before or after the degree.

Librarian Certificate 5 (LC5) – Minimum of 60 hours of college credit from an accredited college or university and 9 college credit hours in library science (3 courses). The library science courses must be 3 credit hours each and may be taken with or after the 60 hours of college credit.

Librarian Certificate 6 (LC6) - High school diploma, GED, or high school equivalency with either (a) 3 years of library experience, or (b) 9 college credit hours in library science. The library science courses must be 3 credit hours each and taken at an accredited college or university.

Please consult the Certification Manual for all certification requirements.

College-Level Library Science Coursework

Courses may be graduate or undergraduate level. To qualify as library science credit for the LC4, LC5, and LC6, the courses must be taken from an accredited college or university and be at least 3 credit hours each. Not-for-credit continuing education courses may be accepted **only if** they meet our policy for college credit substitution (below). *Note: Courses taken for the LC4, LC5, and LC6 need not be from an American Library Association (ALA)-accredited institution or program (but master's degrees for an LC1, LC2, and LC3 must be from an ALA-accredited program).*

Policy on Accepting Not-for-Credit Continuing Education Courses in Lieu of College Credit for the Purpose of Qualifying for the LC4, LC5, and LC6

To substitute a not-for-credit continuing education course for a 3-credit hour college-level library science course, the continuing education course must meet ALL the following criteria:

- 1. Provider The course provider must be affiliated with an accredited higher learning institution. (The purpose is to ensure quality course content.)
- **2. Topic** The applicant must be able to demonstrate that the not-for-credit course content is a topic having to do with administration of a library. (This is required because we are certifying librarians and the rule requires library science courses.)
- **3. Length** The course length must be at least half as long as a typical 3-credit hour semester long course. Courses that are shorter than 8 weeks or that are set up as self-study or self-paced tutorials do not meet our requirements. To count toward an LC4, LC5, or LC6 certificate, the continuing education course must last at least 8 weeks long. (The purpose is to ensure depth of topic coverage is comparable to a 3-credit hour course.)

Substitution: One qualifying continuing education course = one 3-credit hour college course.

Note: Continuing education courses may award Continuing Education Units (CEUs) and sometimes Library Education Units (LEUs). CEUs/LEUs are not equivalent to college credit hours. For the purposes of this policy, please disregard CEU/LEU calculations and follow the requirement regarding course length.
